There will be a variety of ways for contestants to earn points including:

- 1). Can decoration 25% all participants will decorate 1 can to collect money. Cans will be set up at G&W Foods for approximately 2 weeks. Cans will be judged by the Miss Viburnum judges based on overall appearance, creativity, and theme.
- 2). Money collection 50% in the past, participants with the most amount of money collected were the overall winner. While this will still play a part, it is not the only way contestants will be able to earn points.

Cans will still be the primary fundraiser for the Tiny Tot Contest.

3). Drawing 25% - all contestants will be asked to draw a picture to be judged by the Miss Viburnum Judges. The drawings will all be based on the same prompt and will be done at a practice; more information to follow!
